1 **AMENDMENT TO PROPOSED RESOLUTION 2009-17, VERSION 1**

2 On page 1, strike lines 6 through 16, and insert:

3 "WHEREAS, the Board of Supervisors of the King County Ferry District (Board),
4 in Resolution 2008-17.3, approved Vashon Island passenger ferry fares and fare policies
5 to be in effect from January 1, 2009 to June 30, 2009; and

6 WHEREAS, the Board desires to ratify the Vashon Island passenger ferry fares
7 and fare policies for the period during which Washington State Ferries continued to
8 operate passenger only ferry service under an extended agreement with King County
9 from July 1, 2009 to September 28, 2009;

10 WHEREAS, the Board desires to establish new passenger ferry fares and fare
11 policies subsequent to September 28, 2009;

12 BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE KING
13 COUNTY FERRY DISTRICT:

14 Section 1. The Board of Supervisors ratifies the extension of the King County
15 Ferry District’s Vashon Island passenger ferry fares and fare policies established in FD
16 Resolution 2008-17.3 for the period from July 1, 2009 through September 30, 2009
17 included below:
